RESOLUTION AMENDING RESOLUTION 2017-1 ESTABLISHING A NEW FEE
STRUCTURE TO BE CHARGED FOR WATER AND SEWER SERVICE

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE
LUMBERTON MUNICIPAL UTILITY DISTRICT:

SECTION I:

That the Water and Sewer Fees (as shown in Resolution No. 2017-1, Exhibit "A" attached hereto), are hereby changed as follows:

RATES: Minimum Water Usage Bill of 1,500 gals \$14.00 Per Month
 (\$2.30 Per 1,000 from 1,501 gals to 7,000)
 (\$2.90 Per 1,000 from 7,001 gals +)

RATES: Minimum Sewer Usage Bill of 1,500 gals \$13.50 Per Month
 (\$2.35 Per 1,000 Over Minimum)

LATE FEE \$10.00

SECTION II:

The above proposed changes will be effective as of August 1, 2019.

SECTION III:

Should any Section, Paragraph, Sentence, Clause, Phrase or Word of this Resolution be declared unconstitutional or invalid for any reason, the remainder of the Resolution shall not be affected thereby.
